Today, the matter is posted before this Court under the

caption 'For Being Mentioned' at the instance of the learned counsel appearing for the petitioner.

2. The learned counsel appearing for the petitioner submitted that this Court by an order dated 29.04.2025, disposed the petition with direction to the respondent to complete the investigation and file final report. However, on that date, the learned Government Advocate (Crl. Side) submitted that the case has been transferred to Neelankarai Police Station and the same has not been recorded. Hence he prayed for necessary direction.

3. Considering the above submissions, the para Nos.4 and 5 of the order dated 29.04.2025 in Crl.O.P.No.13404 of 2025 shall read as follows :-

“ 4. The learned Government Advocate (Crl. Side) submitted that now the investigation in Crime No.4 of 2023 on the file of the respondent police has been transferred to the file of the All Women Police Station, Neelankarai, Chengalpattu District.
