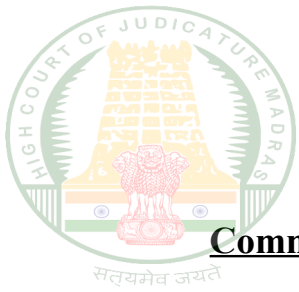

COMMON JUDGMENT

2. Accordingly, these Writ Appeals are **dismissed**. It is open to

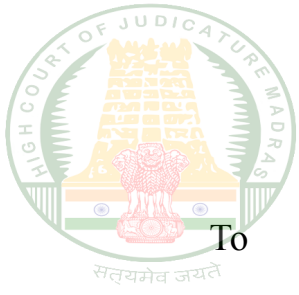
