PRAYER To enlarge the petitioner on anticipatory bail in the event of his arrest by the respondent in Crime No.86 of 2025 on the file of the Respondent.

ORDER

The petitioner who apprehends arrest at the hands of the respondent for the offences punishable under Sections 303(2), 324(3) and 324(4) of BNS, in Crime No.86 of 2025, on the file of the respondent Police, seeks anticipatory

2. The case of the prosecution is that the petitioner along with other accused had committed the theft of trees from a Government Childrens Park at Jolarpet, worth about Rs.50,000/-. Hence, the case.

3. Learned counsel appearing for the petitioner submitted that the allegations are false; that he has been falsely implicated in this case and in any case, custodial interrogation is not required and sought for anticipatory bail.

4. Learned Government Advocate (Criminal Side) appearing for the respondent police, while opposing the grant of anticipatory bail to the petitioner, reiterated the prosecution case and on instructions submitted that the petitioner has no bad antecedents.

5. At this juncture, the learned counsel for the petitioner voluntarily submitted that the petitioner, in order to show his bonafides, is ready and willing to deposit a sum of Rs.10,000/- (Rupees Ten Thousand only) to the credit of Crime No.86 of 2025 without prejudice to his defense.

6. Heard the learned counsel for the petitioner, the learned

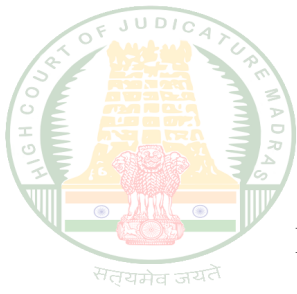
Government Advocate (Criminal Side) appearing for the respondent police

and perused the materials available on record.

7. Taking note of the facts and circumstances of the case, nature of allegations, the submission that the petitioner is willing to deposit an amount of Rs.10,000/- to the credit of Crime No.86 of 2025 and since, custodial interrogation is not required for the purpose of investigation, this Court is inclined to grant anticipatory bail to the petitioner with certain conditions.

8. Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on his appearance, within a period of fifteen days from the date on which the order copy made ready, before the learned **Judicial Magistrate Court No.I, Tirupattur**, on condition that the petitioner shall execute a bond for a sum of **Rs.10,000/- (Rupees Ten Thousand only)** with **two sureties** for a like sum to the satisfaction of the respondent police or the police officer who intends to arrest or to the satisfaction of the learned Magistrate concerned, failing which, the petition for anticipatory bail shall stand dismissed and on further condition that:

[a] the petitioner shall deposit a sum of

Rs.50,000/- to the credit of Crime No.86 of 2025 before the learned Judicial Magistrate No.II, Tirupattur, within a period of two weeks from the date of receipt of a copy of this order.

[b] the petitioner and the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

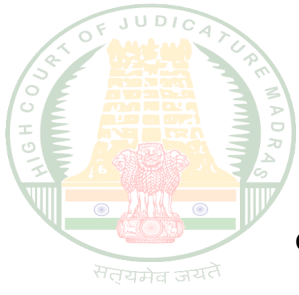
[c] the petitioner shall report before the respondent Police daily at 10.30 a.m., until further orders.

[d] the petitioner shall not tamper with evidence or witness either during investigation or trial;

[e] the petitioner shall not abscond either during investigation or trial;

[f] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in *P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]*;

[g] If the accused thereafter absconds, a fresh FIR

can be registered under Section 269 of B.N.S.
