ORDER

The petitioner is the wife who is arrayed as respondent in H.M.O.P.No.484 of 2024 on the file of Additional Family Court, Coimbatore, which has been filed by the respondent/husband, seeking dissolution of the marriage. The petitioner resides at Thiruvottiyur, Chennai, and also has a child aged 2 years, to be taken care. The petitioner citing inconvenience to attend the hearings at the Family Court, Coimbatore has sought for transfer and the same is acceptable and justifiable.

3. I have also gone through the affidavit filed in support of the transfer application. I am satisfied that the petitioner has made a good ground, seeking



transfer as prayed for.

No costs. Consequently, connected Civil Miscellaneous Petition is closed.
