### **COMMON ORDER**

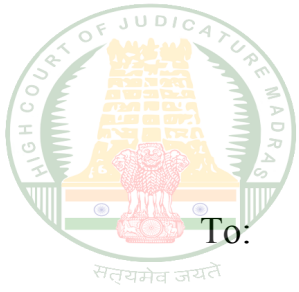
