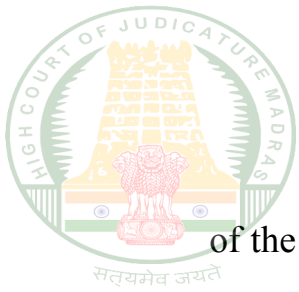

A perusal of Ex.P2, shows that the petitioners are the only surviving legal heirs of the deceased Muthukumar Natesier.

3.The assertions in the petition have been duly proved by adducing oral evidence supported by documents. In these circumstances, the petitioners are entitled to the relief.

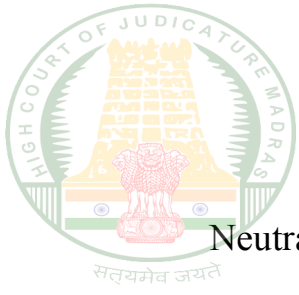
