ORDER

[made by M. SUNDAR, J.]

Subject matter of captioned 'writ petition' [hereinafter 'WP' for the sake of brevity] is alleged encroachment in 'Survey No.61/10, Asakalathur Village, Kallakurichi Taluk and District' (hereinafter 'said land' for the sake of convenience and clarity).

2. Request for removal of aforesaid alleged encroachment by way of representation dated 03.04.2025 has not yielded results and that has necessitated captioned WP, is the submission of Mr.V.Gunasekar, learned counsel for writ petitioner.

3. Issue notice to official respondents (RR 1 to 3).

4. Mr. T.K. Saravanan, learned Additional Government Pleader, accepts notice for official respondents. Learned State counsel submits that survey of said lands will be done within a period of six weeks from today, *i.e.*, on or before 05.08.2025, and depending on the outcome of the survey, action for removal of encroachment (if found) will be commenced *vide* the Tamil Nadu Land Encroachment Act, 1905 (Tamil Nadu Act III of 1905) as expeditiously as the business of official respondents would permit but in any event within a period of six weeks therefrom, *i.e.*, on or before 16.09.2025. This submission is recorded.

5. Though obvious, we make it clear that all the rights and contentions of R4 stand preserved and this order does not impinge upon his rights. Therefore, there is no impediment in dispensing with notice to R4 and taking up the captioned WP with the consent of the learned State counsel and learned counsel for writ petitioner. We do so.



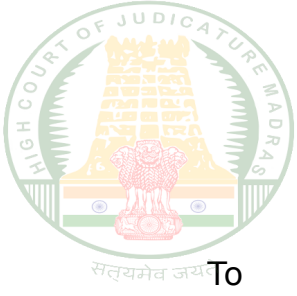
