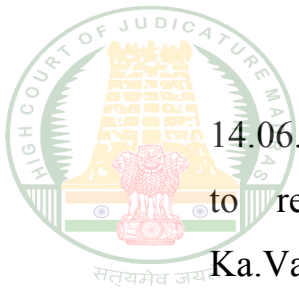

ORDER

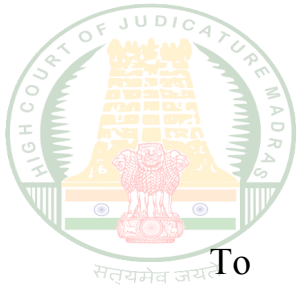
The learned counsel for the petitioner submitted that this writ petition has been filed for issuance of planning permission.
