This petition has been filed seeking modification of the bail order condition No.(ii) passed by the learned Additional Chief Metropolitan Magistrate, E.O-II, Egmore, Chennai, in Crl.M.P.No.138 of 2019 dated 25.01.2019.

2. The learned counsel appearing for the petitioner submitted that learned Additional Chief Metropolitan Magistrate, E.O-II, Egmore, Chennai in Crl.M.P.No.138 of 2019 has granted bail to the petitioner with a conditions that *"(ii) the petitioner / accused should furnish two sureties each to the value of Rs.50,000/- showing property in their name to the satisfaction of the Court"*. Now, the petitioner seeks modification of the order.

3. Considering the facts and circumstances of the case, this Court modifies the above conditions to the effect that *"(ii) the petitioner / accused should furnish two sureties each to the value of Rs.50,000/- showing property in their name to the credit of E.O.C.C.No.141 of 2019 and the Trial Court shall deposit the same in an interest bearing account"*.
