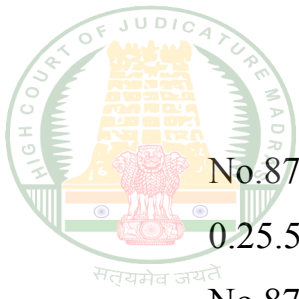

No.87/2, of an extent of 0.16.0 hectares, Survey No.87/7 to an extent of 0.25.5 hectares, Survey No.87/8 of an extent of 0.19.0 hectares, Survey No.87/9 of an extent of 0.39.5 hectares, Survey No.87/10 of an extent of 1.16.0 hectares and Survey No.87/11 of an extent of 0.24.0 hectares, totalling to 1.40.0 hectares in Mohur Village, Sankarapuram Taluk, Kallakurichi Taluk, Then Villupuram District and pass such further or other orders as this Hon'ble Court may deem fit and proper in the facts and circumstances of the case and thus render justice, is ordered as prayed for.
