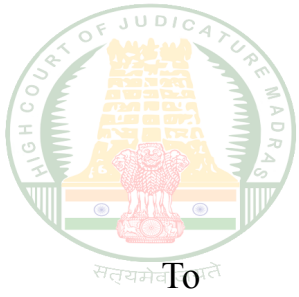
This petition is filed to Grant Leave to the applicant herein to file a third party review against the order of this Court dated 15.04.2025 in W.P.No.11129 of 2025.
