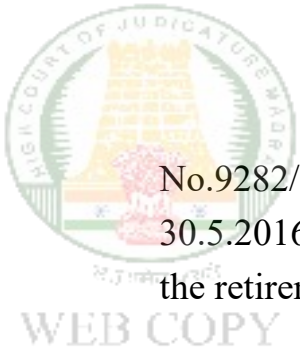

PRAYER

This Writ Petition is filed under Article 226 of Constitution of India seeking Writ of Certiorarified Mandamus to call for the records of the 1st respondent in Letter No.9282/ E2/2016-2, dated 30.05.2016 and Letter



No.9282/ E2/2016-5 dated 26.09.2016 and quash the proceedings dated 30.5.2016 and 26.9.2016 and consequently direct the respondents to settle all the retirement benefits of the petitioner.
