ORDER

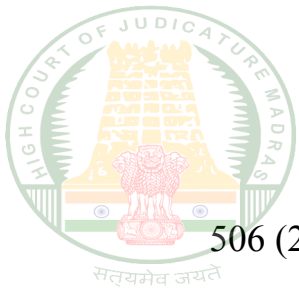
This writ petition has been filed seeking police protection to the petitioner, his family and the properties, which is under his responsibilities.
