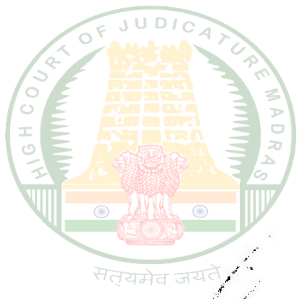

COMMON MEMO FILED ON BEHALF OF APPELLANT

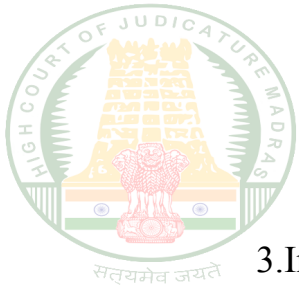

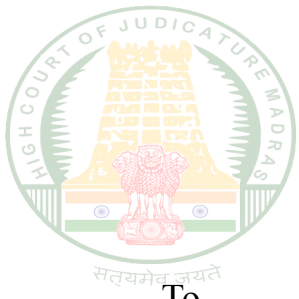
