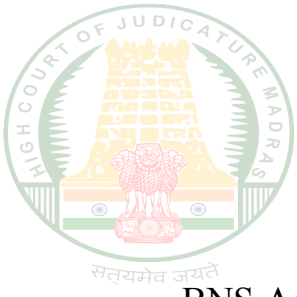

ORDER

The petitioner, who was arrested and remanded to judicial
custody on 20.04.2025, for the offences punishable under Sections 303 (2) of

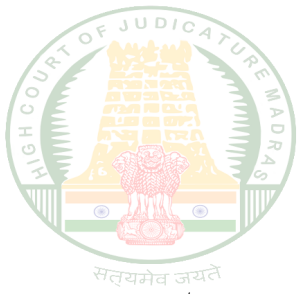
BNS Act (379 I.P.C) r/w 21 (1) of Mines and Minerals Act in Crime No.107

of 2025, on the file of the respondent police, seeks bail.

2.The case of the prosecution is that the petitioner was found in illegal transportation of 1 unit of sand. Hence the case.

3.Learned counsel appearing for the petitioner submitted that the petitioner is an innocent and he has been falsely implicated in this case. Petitioner has not committed any offence as alleged in the FIR. He would further submit that the petitioner was arrested and is in judicial custody from 20.04.2025. He would submit that the petitioner, without prejudice to the defence and contention, is ready and willing to deposit a sum of Rs.5000/-, to any welfare scheme of the Government or any other organization. He further submits that the petitioner is ready to abide by any stringent condition that may be imposed by this court.

4. The learned Government Advocate (Crl.Side) appearing for the respondent police submitted that the petitioner was found in illegal

transportation of 1 unit of sand. Hence, opposed to grant bail to the petitioner.

5. Heard both sides and perused the materials available on record including the First Information Report.

6. Considering the voluntary submission made by the learned counsel for the petitioner, the petitioner is directed to deposit a sum of **Rs.5000/- (Rupees Five Thousand only)** as non-refundable deposit, to the credit of the **Madras High Court Advocate Clerks Welfare Association, Chennai, Indian Bank Branch, High Court, (A/c No. 484077244) IFSC Code : IDIB000M157**, without prejudice to the right of defence before the Trial Court and making it clear that it would not amount to admission of guilt.

7. Further, considering the nature of offence and the period of incarceration undergone by the petitioner and considering all others factors, I am inclined to grant bail to the petitioner, subject to certain conditions.

8. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of **Rs.10,000/- (Rupees Ten Thousand only)** with two sureties, each for a like sum to the satisfaction of the **learned District Munsif Cum Judicial Magistrate, Vedaranyam**, and on further conditions that :-

[a] the petitioner shall report before the respondent police, everyday at 10.30 a.m., for a period of three months and thereafter as and when required for interrogation.

[b] the petitioner shall not commit any offences of similar nature.

[c] the petitioner shall not abscond either during investigation or trial.

[d] the petitioner shall not tamper with evidence or witness either during investigation or trial.

[e] On breach of any of the aforesaid conditions, the learned Judicial Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].
