ORDER

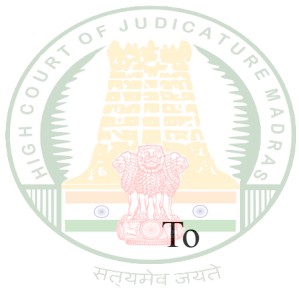
This Petition is filed seeking extension of time by four weeks to enable the petitioner to file his detailed objections to the show cause notice dated 27.07.2016.

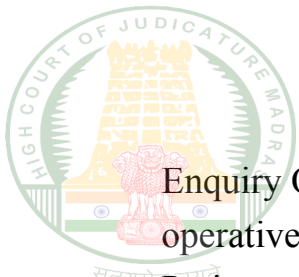
