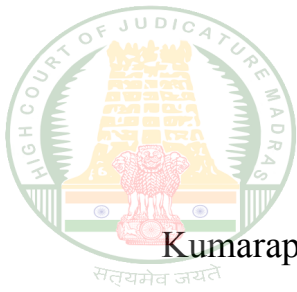

In view of the above, the Judgment dated 14.02.2025 passed in C.A.No.20 of 2024 by the learned II Additional District and Sessions Judge, Tiruchengode confirming the judgment and conviction dated 27.11.2023 passed by the Judicial Magistrate, Kumarapalayam in S.T.C.No.279 of 2020 are hereby set aside and the terms of Joint Memo of Compromise, dated 03.07.2025 shall form part and parcel of this order.

5. Accordingly, this Criminal Revision Case stands allowed.
