3. We therefore direct the respondents to shift the petitioner to Rajiv Gandhi Government General Hospital for surgery and appropriate treatment.



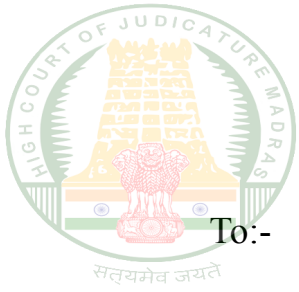
