Mitha Bhai, No.13/1, Second Cross Street, Chrompet, Bangalore-560 018 and now confined at Central Prison, Puzhal, Chennai, Tamil Nadu, before this Court and set him at liberty.

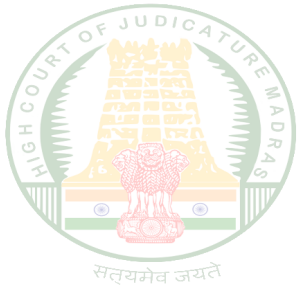
