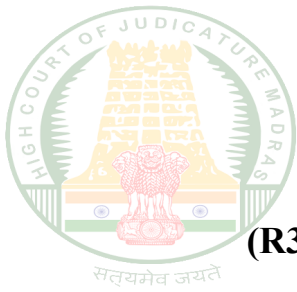

3. However, with the intention of giving an opportunity to writ petitioner and learned counsel for writ petitioner, list this matter on Monday but under the cause list caption 'FOR DISMISSAL'.

2. Pursuant to aforementioned proceedings, captioned matter is listed under the cause list caption 'FOR DISMISSAL' today but the position is no different today as regards the writ petitioner. 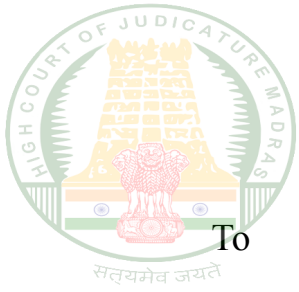
