2. Hence, this miscellaneous petition is dismissed.

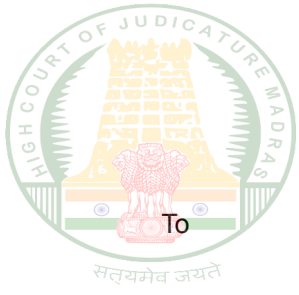
