Mr.Muthuppan, learned counsel for the petitioner seeks permission of the court to withdraw this Writ Petition.

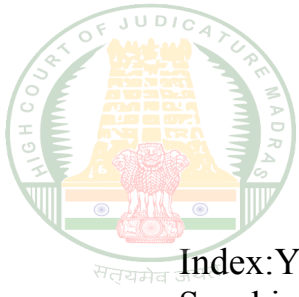
2. Permission is granted. Accordingly, the writ petition stands dismissed as withdrawn. No costs. Consequently, connected miscellaneous petitions are closed.
