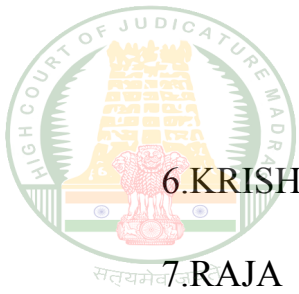

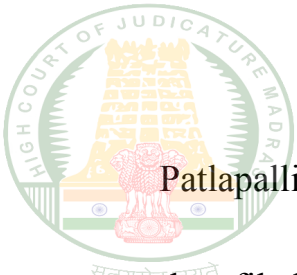

5. In such case, whenever there is a law and order problem, it is the duty of the Police to give necessary protection to the petitioner.

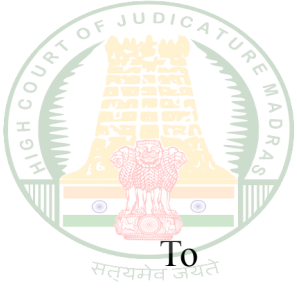
