Unfortunately, the petitioner's daughter-in-law (daughter of the third Respondent) passed away. Subsequently, the petitioner's son also passed away. The petitioner's grievance is that the third respondent is not allowed to see her grandchild and that led to the filing of the Habeas Corpus Petition.

2. On 21.05.2025, we directed the second respondent to cause the
