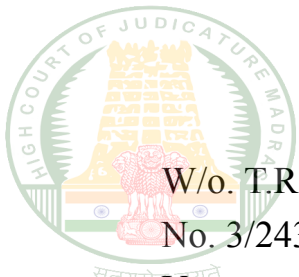

3. Learned Senior Counsel appearing on behalf of the 4th respondent submitted that eventhough the 4th respondent was permitted to enter into the



ground floor, she is neither comfortable nor peaceful because of the attitude of the petitioner.

4. In the considered view of this Court, it is very difficult for this Court to monitor the relationship between the petitioner and the 4th respondent in a writ petition. In any case, in view of the earlier order passed on 03.06.2025, the 4th respondent is already in possession of the ground floor of the property. The other issues can be worked out before the competent civil court in the manner known to law.

5. With the above observation, this writ petition is closed. No costs. Consequently, the connected Miscellaneous Petitions, if any, are closed.
