5. The Writ Petition is disposed of accordingly. There shall be no order as to costs. Consequently the connected miscellaneous petition is closed.

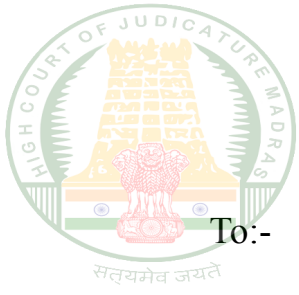
