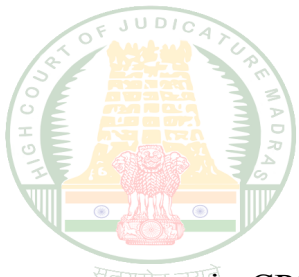

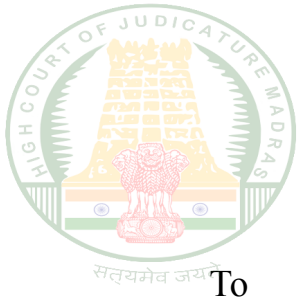
COMMON ORDER
