3. Accordingly, this Writ Petition is dismissed for non prosecution.

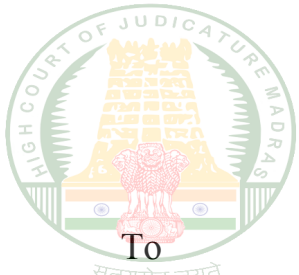
