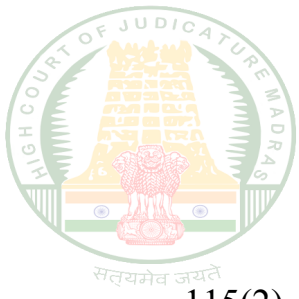

ORDER

The petitioner, who was arrested and remanded to judicial custody
on 06.05.2025 for the alleged offence punishable under Sections 296(b),

115(2), 118(1), 109 and 351(3) of BNS, 2023 in Crime No.155 of 2025, on the file of the respondent police, seeks bail.

2. The case of the prosecution is that due to previous enmity, petitioner along with other accused assaulted the defacto complainant using knife, as a result of which, defacto complainant sustained injuries. Hence the case.

3. Learned counsel appearing for the petitioner submitted that the petitioner is an innocent person and he has been falsely implicated in this case. He would further submit that the petitioner was arrested and he is in judicial custody from 06.05.2025 and he ready to abide by any conditions that may be imposed by this Court. Hence, he prayed for grant of bail to the petitioner.

4. Learned Government Advocate (CrI.Side) appearing for the respondent police while opposing to grant bail to the petitioner, reiterated the case of the prosecution.

5. Heard both sides and perused the materials available on record.

6. Considering the submissions of the learned counsel on either side and the period of incarceration undergone by the petitioner, and also considering all others factors, this Court is inclined to grant bail to the petitioner, subject to certain conditions.

7. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of Rs.15,000/- (Rupees fifteen Thousand only) with two sureties, each for a like sum to the satisfaction of the learned **Xth Metropolitan Magistrate, Egmore, Chennai** and on further conditions that:-

[a] the petitioner shall deposit a sum of Rs.5,000/- to the credit of Crime No.155 of 2025 before the Xth Metropolitan Magistrate, Egmore, Chennai

[b] the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the concerned Magistrate/Judge may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity;

[c] the petitioner shall report before the respondent police daily at 10.30.a.m., for a period of two months and thereafter, as and when required.

[d] the petitioner shall not abscond either during investigation or trial;

[e] the petitioner shall not tamper with evidence or witness either during investigation or trial;

[f] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in *P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]*;

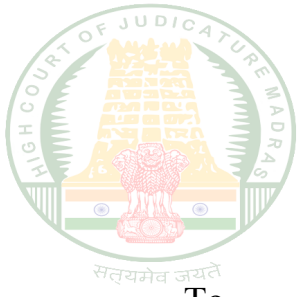
[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 B.N.S.
