JUDGMENT

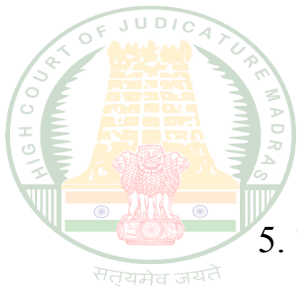
(Judgment of the Court was delivered by **S.M.SUBRAMANIAM, J.**)

The Writ Appeal has been instituted against the Writ Order dated 03.03.2025 passed in W.P.No.3955 of 2025.

2. The Appellant before this Court is a 3rd party and by obtaining leave, instituted the present Writ Appeal.

3. Perusal of the Writ Order impugned, shows that based on the written instructions from the Tahsildar, a direction was issued to complete the process of inquiry within a period of four weeks.

4. It is needless to state that the Tahsildar has to conduct inspection and survey and also conduct an inquiry by affording an opportunity to all the parties and pass appropriate orders on merits and in accordance with law.

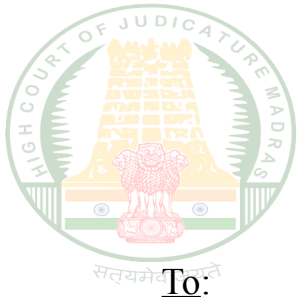
