ORDER

When the matter came up for hearing the learned counsel for the petitioner submits that even though the petitioner claimed for conferment of permanent status and got an award, they are not in employment and they have never even reported for employment neither they have come before this Court. 2.In that view of the matter, the adjudication is necessary, if only the employees come to the Board, seeking for implementation of the order, since at
