ORDER

By this writ petition, the petitioner seeks a direction to the 2nd respondent to dispose of rectification petition No.277218 of 2022 in relation to Trade Mark No.5231371 for the trade mark MANJAL RESTAURANTS.

2. In the affidavit in support of this petition, the petitioner has set out details relating to the prosecution of the rectification petition at paragraph 23 of the affidavit. The said details reveal that evidence was adduced by both parties by 07.03.2024. Learned counsel for the petitioner, therefore, submits that the next step is to fix a date for oral arguments.

3. Without prejudice to the merits of the matter, learned counsel for the 1st respondent submits that the said respondent has no objection to the expeditious disposal of the rectification proceedings.
