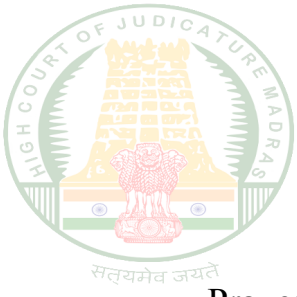

The petitioner, who is the owner of the property on which TASMACH Shop No.4381 is located, seeks to prevent the closure or shifting of the shop.



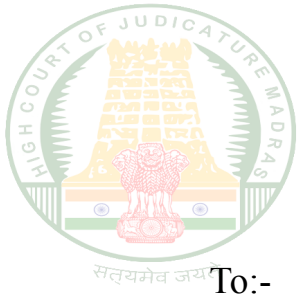
