This Court while disposing of the present writ petition on 03.06.2025 directed the Superintendent of Police, Cuddalore District, the Deputy Superintendent of Police, Cuddalore District and the Inspector of Police, Ramanatham Police Station, Cuddalore District to appear before this Court on 04.06.2025 at 10.30 a.m., since the impugned reply of the Sub-Inspector of Police of the second respondent Police Station, is without any authority.
