ORDER

The petitioner had filed a petition under Section 528 BNSS, seeking directions to the Special Court of Scheduled Caste and Scheduled Tribes (Prevention of Atrocities), Act, Vellore, to accept the surrender of the petitioner/accused No.4 and consider the bail application on the same day in connection with Crime No.360 of 2024 on the file of the first respondent police.

2 This Court by an order dated 15.05.2025 disposed of the petition by directing the Special Court of Scheduled Caste and Scheduled Tribes (Prevention of Atrocities) Act, Vellore to consider the petitioner's bail application and certain directions were also issued.

3 Now the petitioner has filed the present miscellaneous petition seeking to amend the Court name as Principal District Judge, Ranipet, instead of the Special Court of Scheduled Caste and Scheduled Tribes (Prevention of Atrocities) Act, Vellore, stating that due to bifurcation
