ORDER

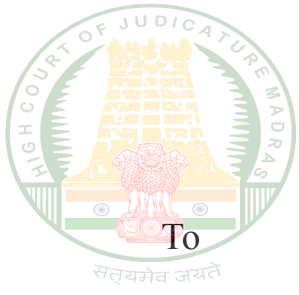
(Order of the Court was made by *SENTHILKUMAR RAMAMOORTHY, J.*)
