4. In reply, the learned Government Advocate (Taxes) appearing for



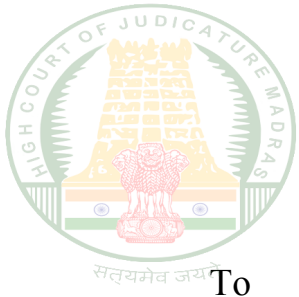
