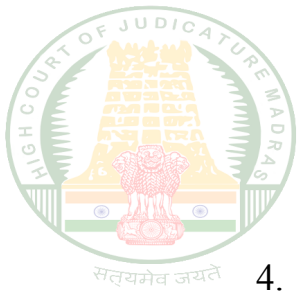

Likewise, in this case, the petitioner is permitted to pay the additional security deposit of Rs.64,17,005/- in six equal monthly installments. The first installment shall be paid on or before 17.06.2025 and the subsequent installments shall be paid on or before the first of each succeeding month over the next five months. In the event of default, the petitioner shall lose the benefit of this order and the respondents shall be at liberty to initiate appropriate legal proceedings in respect thereof.

This Writ Petition is disposed of on the above terms. No costs.
