COMMON ORDER

(Order of the Court was made by the Hon'ble Chief Justice)

The impugned orders in all the appeals shall stand stayed.

2. Assesseees may reply to the notice issued under Section 148A of the Income Tax Act, 1961. The Assessing Officer shall pass a reasoned order after giving a personal hearing to assesseees, notice whereof shall be communicated at least five working days in advance.

2. If the order to be passed is adverse to assesseees, it shall not be acted upon for a period of two weeks. At that stage, assesseees may apply, if these appeals are not already disposed of, for early hearing of these appeals.

3. If the Assessing Officer is going to rely on any order or judgment of any Tribunal or Court, a list thereof shall be made available along with the notice for personal hearing, so that assesseees may deal with/distinguish the same.
