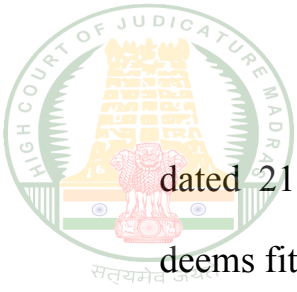

2. The learned Government Advocate(crl.side) appearing for the respondent police submitted that the petitioners are complying with the aforementioned condition regularly.

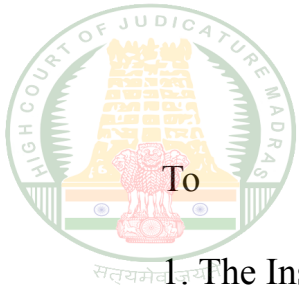
