2. The learned counsel for the petitioner would submit that though certain disciplinary proceedings were initiated against the petitioner, all the disciplinary proceedings have now been completed. Now, the petitioner is on the verge of retirement. Therefore, the petitioner has submitted his representation dated 08.04.2025, requesting an order in line with the order passed in W.P.Nos.24873 and 25147 of 2019.
