Prayer in Arb.Appln.No.273 of 2021:

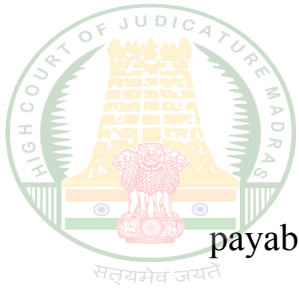
