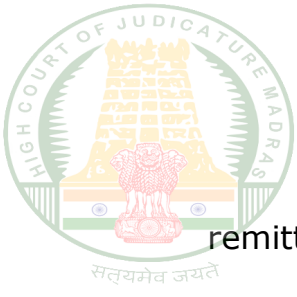

ORDER

The writ petition has been filed seeking issuance of Writ of Certiorarified Mandamus calling for the records relating to the 39 recovery proceedings No.Sa.Mu.Aa S2.336/22 dated 22.07.2024 of the second respondent and quash the same in the light of the orders passed in W.P.Nos.20331, 20343, 20346, 20348, 20349, 20029, 20033, 20037 and 20042 of 2024 dated 30.10.2024 with a further direction to refund the amount already recovered.
