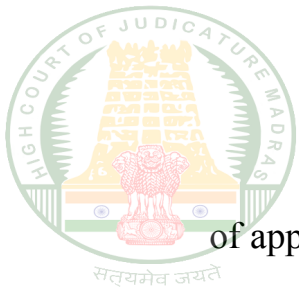

JUDGMENT

2. Incidentally, the writ petition had originally been filed challenging only the order of the Zonal Deputy Tahsildar dated 22.02.2023. Even prior to the institution of the writ petition the petitioner, had challenged the order of the Tahsildar also by way of statutory appeal before the RDO, riding two horses simultaneously. Pending writ petition, the appeals filed before the RDO came to be disposed and the prayer was consequently amended.

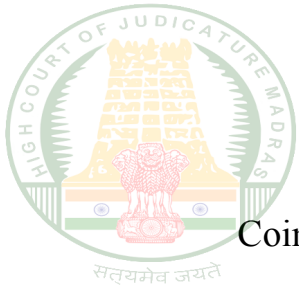
3. Dismissed with no order as to costs.
