The petitioner was granted anticipatory bail by this Court in Crl.O.P.No.11432 of 2025 by order dated 30.04.2025, in which, one of the condition imposed is that the petitioner shall appear before the respondent police daily at 10.30 a.m. It was further recorded that as and when the cases papers are transferred and on summons, the petitioner shall appear before the Bangalore Police daily until it is relaxed by the jurisdictional Court at Bangalore.

2.The learned counsel for the petitioner submitted that the petitioner is complying with the earlier order of this Court by appearing before the respondent and the same may be considered. He further submitted that the Bagalur Police not to project as though the petitioner has not complied with the condition and absconding.

3.The learned Government Advocate (Crl. Side) produced the proceedings issued by the Director General of Police, Tamil Nadu in Rc.No.9398558/Crime 2(2)/2025 dated 07.02.2025 addressed to the Director
