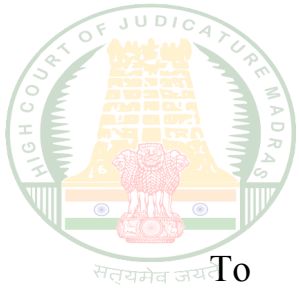
2. The learned Additional Public Prosecutor states that the petitioner is complying with the condition without fail.
