PRAYER : Criminal Original Petition filed under Section 483 of Bharatiya Nagarik Suraksha Sanhita, 2023, to enlarge him on bail pending before the Principal Special and District Sessions Judge NDPS Court Chennai case connected in Crime No.192 of 2025 (on the file of the Inspector of Police, N-2, Kasimedu Police Station, Tamil Nadu).

ORDER

The petitioner, who was arrested and remanded to judicial custody on 20.04.2025, for the offences punishable under Sections 8(c) r/w 20(b)(ii)(B) of

Narcotic Drugs & Psychotropic Substances Act, 1985 in connection with Crime No.192 of 2025, registered on the file of the respondent, seeks bail.

2. The case of the prosecution is that petitioner was found to be in illegal possession of 1.200 kgs of Ganja. Hence, the case.

3. The learned counsel for the petitioner submitted that the petitioner has been interrogated by the respondent and the investigation is over. In the event of granting bail the petitioner will not hamper or tamper the witness. He further submitted that the petitioner is ready to abide by any stringent condition that may be imposed by this Court. Hence, he prayed for grant of bail to the petitioner.

4. Learned Government Advocate (Criminal Side) appearing for the respondent police, while opposing for grant of bail to the petitioner, reiterated the prosecution case and submitted that the petitioner has 16 previous cases.

5. Heard both sides and perused the materials available on record.

6. Considering the facts and circumstances of the case, submissions

made by the learned counsels on either side and the period of incarceration undergone by the petitioner, this Court is inclined to grant bail to the petitioner with certain conditions.

7. Accordingly, the petitioner is ordered to be released on bail on his executing a bond for a sum of **Rs.10,000/- (Rupees Ten Thousand only)** with **two sureties**, each for a like sum to the satisfaction of the learned **XVI Metropolitan Magistrate Court, George Town, Chennai** and on further conditions that:

[a] the sureties shall affix their photographs and Left Thumb Impression in the Application for Surety ship [Judicial Form No.46 annexed to 'The Criminal Rules of Practice, 2019']. The learned Magistrate shall obtain a copy of any one of the identity proofs to ensure their identity;

[b] **the petitioner shall report before the respondent Police, everyday at 10.30 a.m., until further orders except when he required to appear before the trial Court for hearing in connection with other case;**

[c] the petitioner shall make himself available for

interrogation by a Police Officer as and when required;

[d] the petitioner shall not directly or indirectly cause any threat to the de facto complainant and witnesses;

[e] the petitioner to give an undertaking that if required for being identified by witnesses during investigation or for police custody beyond the first fifteen days, he shall comply to the directions as may be given by the Court in this regard;

[f] On breach of any of the aforementioned conditions, the learned Magistrate/Trial Court is entitled to pass appropriate orders against the petitioner in accordance with law as if the aforementioned conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)13 SCC 283]**;

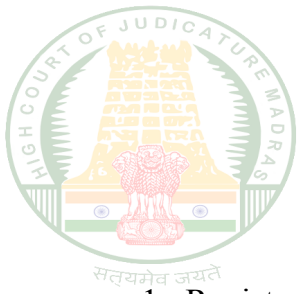
[g] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 of B.N.S.
