ORDER

This writ petition has been filed to direct the 1st respondent to deal with the petitioner's representation dated 30.05.2023, wherein the petitioner is seeking for revocation of the passport issued in favour of the 2nd respondent.

2. The learned Senior Panel Counsel appearing on behalf of the 1st respondent submitted that the passport was issued in favour of the 2nd respondent after conducting a proper enquiry and after obtaining a report from the police. There is a matrimonial dispute between the petitioner and the 2nd respondent.

3. It is not necessary for this Court to go into the issues raised in the present writ petition and it will suffice if a direction is given to the 1st respondent to deal with the representation made by the petitioner on 20.06.2023 and take a decision in accordance with law, after affording an opportunity to the 2nd respondent, within a period of six weeks from the date of receipt of a copy of this order.



4. This writ petition is disposed of, with the above terms. No costs.

Consequently, the connected miscellaneous petitions, if any, are closed.
