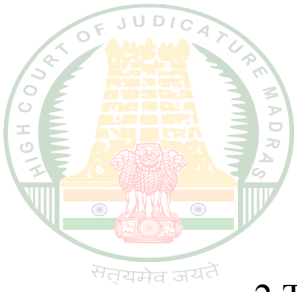
PRAYER:- Criminal Original Petition filed under Section 482 of Bharatiya

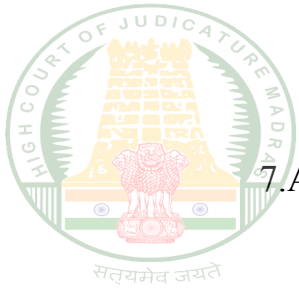
2.The case of the prosecution is that the petitioners are involved in child trafficking. Hence the case.

3.The learned counsel appearing for the petitioners submitted that the petitioners are innocent persons and they had been falsely implicated in this case. He further submitted that the custodial interrogation of the petitioners is not required and sought for anticipatory bail to the petitioners.

4.The learned Government Advocate (Crl.Side) reiterated the prosecution case and opposed for grant of anticipatory bail to the petitioners.

5.Head the learned counsels on either side and perused the records.

6.Since, the petitioners had committed very serious and heinous offence, the custodial interrogation of the petitioners is very much required. Hence, this Court is not inclined to grant anticipatory bail to the petitioners.



7. Accordingly, this Criminal Original Petition is dismissed.
