ORDER

The writ petition has been filed to direct the respondents to pay earned leave salary and salary for leave on private affairs to the petitioner along with 18% interest per annum for the delayed period from 30.05.2014 till the date of actual payment.

2. The case of the petitioner is that, he sent a representation to the 3rd respondent dated 18.02.2025, claiming earned leave salary and also salary for leave on private affairs and the said representation is pending with the 3rd respondent. Hence the present writ petition has been filed seeking for a mandamus.

3. Heard the learned counsel for both sides and perused the materials available on record.

4. Learned Standing Counsel for the 3rd respondent would fairly submit that they would consider the petitioner's representation within a
